THE PRESIDENT HAS THE AUTHORITY TO ESTABLISH COMPENSATION FOR ALL OTHER STAFF AND THE COMPENSATION IS BASED ON JOB DESCRIPTIONS AND PERFORMANCE REVIEWS. COMPENSATION LEVELS ARE SET BY THE PRESIDENT AND APPROVED BY THE BOARD AS PART OF THE ANNUAL BUDGET.

THE FUND ACTED AS AN AGENT FOR THE COUNTIES AND THE PASS-THROUGH RENTAL ASSISTANCE IS NOT RECORDED IN THE 2020 STATEMENT OF ACTIVITIES. THE FUND EARNED A FEE OF \$369,052 FOR THE ADMINISTRATION OF THIS PROGRAM WHICH IS RECORDED AS GOVERNMENT GRANTS REVENUE IN THE 2020 STATEMENT OF ACTIVITIES.
